



2006 MAMMAL AND BIRD REHABILITATOR LIST

Thank you for caring about wildlife. Their fate is in your hands, and we appreciate you taking the time to give them the best possible chance at a good life. If you don't find a rehabilitator for a particular animal in your own county, try the next closest county, or *any* county, at least to get advice from an expert. If you are at a total loss, or no one is returning your calls, please call the Division of Fish and Wildlife to see if they have any recent additions to this list.

Attached you will find the list of wildlife rehabilitators that you requested. It is current as of January 2006; however, should you find that a phone number is wrong, the person no longer takes in animals or the type of animals they handle has changed, kindly call our office and let us know so that we may update our files. In addition, if you have a particularly bad (or good) experience with any one of the rehabilitators please let us know so that we may include that in our updated listings.

We advise keeping one copy at home and another copy in your car so you can have the information handy wherever you are.

PLEASE NOTE: NJ licensed veterinarians may take temporary possession of wildlife and/or provide medical treatment of wildlife while making arrangements to transfer the animals within 48 hours to a currently licensed wildlife rehabilitator licensed for that species. Some veterinarians, while wanting to help, may feel they are not permitted to do so by law. If you come across such a veterinarian, please direct him or her to the state Division of Fish & Wildlife's website at: <http://www.state.nj.us/dep/fgw/rehablst.htm>, which shows that they have the state's permission to take in and care for wildlife.
